Official Contest Rules

1. No purchase necessary to enter or receive a prize.
2. Contest is open to legal residents of the United States, 18 years of age or older, with the exception of employees and the immediate families of Holston Valley Broadcasting Corporation and their partners, affiliates, subsidiaries, or agencies. Limit one entry per person, per day. WRZK reserves the right to forfeit contestants if multiple entries per day are sent and/or the entry system is abused.
3. Prizes are non-transferable. No substitution of prize or exchange for cash. Limit one prize from WRZK per family or household per 30 days.
